Applications are invited for filling up six posts of Peons, on temporary basis, five for general category and one reserved for the Physically handicapped category, on the establishment of the High Court Registry, in the pay band of ₹ 4900-10680 + ₹ 1300/- Grade Pay + ₹ 240/- Secretariat Pay, from amongst the matriculate candidates. In the physically handicapped category, the candidature of only those candidates shall be considered who are suffering from blindness or low vision, provided that the disability is not more than 40%. The applications should reach the Registry of the High Court on or before **08.12.2014**. Those who are already in Government service should get their applications forwarded through proper channel in accordance with the rules.

The lower and upper age limit of the candidates shall be the same as applicable to the corresponding employees of the State Government. Applications found incomplete or received after **08.12.2014** shall not be entertained.
