### **IMPORTANT NOTES**

1. The applications received after the due date or incomplete applications shall be outrightly rejected and no correspondence will be entertained in that respect. The words **“Applications for the post of Additional District and Sessions Judge”** should be super scribed on top of the envelope containing the application form.
2. Only such Judicial Officers who are found eligible and whose applications are complete in all respects shall be entitled to participate in the written examination. A list of such candidates shall be displayed on the website of the High Court from 15.6.2014 onwards. The Judicial Officers are, therefore, advised to visit the High Court website <http://hphighcourt.nic.in> for this purpose.
3. The admit cards for the written examination to the eligible Judicial Officers, including therein, inter alia, the venue and location of the examination centre shall be

issued to them as per the time schedule, referred to above.

4. Result of the written examination shall be displayed on the website of the High Court <http://hphighcourt.nic.in> on 16.8.2014. The Judicial Officers, are, therefore, advised to visit the High Court website on or after 16.8.2014.
5. For eligibility criteria, please refer to Rule 5 and 6 of the H.P. Judicial Service Rules, 2004 read with H.P. Judicial Service (1<sup>st</sup> amendment) Rules, 2008.
6. One copy of pass port size photograph in addition to the photograph affixed on the application form.
