## OFFICE ORDER

2. The appointments will be subject to the verification of the character antecedents and medical fitness of the appointees. A certificate is to be obtained from the Medical Authority, to whom the appointees shall be referred to, by this Registry;
3. The attested copies of certificate(s), showing the date of birth and educational qualification etc., are required to be furnished at the time of joining;
4. The appointees are required to furnish two certificates from any two Gazetted Officers that they bear good moral character;
