OFFICE ORDER

In exercise of the powers vested in His Lordship under Article 229 of the Constitution of India read with Rule 4 and 19 of the Himachal Pradesh High Court Officers and the Members of the Staff (Recruitment, Conditions of Service, Conduct & Appeal) Rules, 2003, and all other powers enabling in this behalf, Hon'ble the Chief Justice is pleased to appoint Sh. Subhash Chand s/o Sh.Phoola Singh, Vill. Batari, PO Arhal, Distt. & Tehsil Rohru, Pakriti Niwas, Kanlog, Shimla-171001, as Cook-cum-Chowkidar, in the Pay Band of ₹ 4900-10680 + ₹ 1300/- Grade Pay with initial start of ₹ 6200/- + ₹ 240/- as Secretariat pay, on temporary basis with immediate effect, subject to fulfillment of the following terms and conditions:-

1. The appointee will remain on probation for a period of two years. During this period, the appointment will be liable to be terminated at any time without assigning any prior notice, if his work and conduct is not found satisfactory.
2. The appointment will be subject to the verification of the character antecedents and medical fitness of the appointee. A certificate is to be obtained from the Medical Authority, to whom the appointee shall be referred to, by this Registry;
3. The attested copies of certificate(s) showing the date of birth and educational qualification etc., are required to be furnished at the time of joining;
4. The appointee is required to furnish two certificates from any two Gazetted Officers that he bears good moral character;
5. The appointee is required to furnish a certificate to the effect that he has not entered into bigamy, in case he is married;

The appointee is required to join his duties within a fortnight of the receipt of this Office Order, failing which his appointment shall stand as cancelled.
