2. The last date for the receipt of tender(s) in the High Court Registry is 28th November, 2016. The tender (s) received after due date shall be rejected and not taken into consideration.
3. The rates shall be quoted F.O.R., High Court Registry.
4. The Law Books etc. should be amended/update and standard publications as mentioned in the list.
5. The Registrar General, High Court of Himachal Pradesh, reserves the right to accept or reject any tenders without assigning any reason.
6. Every tender should be accompanied by an earnest money to the extent of 5% of the tender amount in the shape of demand draft or bank guarantee in the name of The Registrar General, High Court of H.P., Shimla. The tender(s) received without earnest money shall be liable to be rejected. Preference shall be given to the suppliers giving maximum discount.
7. The successful tenderer, shall have to deposit the performance security to the extent of 5% of the value of the contract within a week after acceptance of the contract.
