REGULATIONS FOR HOLDING DEPARTMENTAL EXAMINATION FOR DIRECT RECRUITS TO THE CADRE OF DISTRICT JUDGES REGULATIONS, 2005.

NOTIFICATION

In exercise of the powers conferred under Rule 2 read with Rule 18 of the Himachal Pradesh Judicial Service Rules, 2004, the Hon'ble High Court of H.P., is pleased to make the following Amendment in "The Himachal Pradesh Judicial Service (Departmental Examination for Direct Recruits to the cadre of District Judges) Regulations, 2005".

- SHORT TITLE: 1. These Regulations may be called "The Himachal Pradesh Judicial Service (Departmental Examination for Direct Recruits to the cadre of District Judges) (First amendment) Regulations, 2013."
- COMMENCEMENT: 2. These Regulations shall come into force with immediate effect.
- Amendment 3. In the Schedule of the aforesaid Regulations, in First Paper (Criminal Law item at Sr. No.(G) shall stand deleted and in its place Food Safety and Standards Act, 2006 shall be substituted/added.
