#### **NOTE(S):-**

1. Out of 14 anticipated post(s) ONLY 09 posts are made available for posting. Therefore, the result only qua 11 Regular vacancies (09 anticipated + 02 posts on account of non-joining) are declared along with the allocation of Civil & Sessions Division(s), solely on the basis of the Merit List & availability of posts.
2. Civil & Sessions Divisions are allocated firstly on the basis of preference of choice as per Merit & when all the preferred stations of choice are exhausted, then the stations have been allocated on availability of post(s).
3. If two or more candidates have scored equal marks, the candidate elder in age has been given preference in the appointment.
4. The result regarding Contractual & Daily Wage Post(s) will be declared, after the joining of candidates against 11 Regular Vacancies.
5. Appointment Letter(s) will be issued by the concerned District & Sessions Judge(s).
