- **2.** The Practical Test (50 Marks) shall be of one-hour duration, i.e., 10 AM to 11:00 AM.
- **3.** Viva Voce of 25 marks, in the ratio of 1:3 will be done based on the performance of candidates in written as well as practical test subject to the condition that the successful candidate has secured fifty percent (50%) marks in the written examination and sixty percent (60%) in the practical test.
