Note: Only those documents will be verified, which the candidates have uploaded at the time of submission of Online Application Form, as per Rule 8 (y) of "The Himachal Pradesh District Judiciary Staff (Recruitment, Promotion, Control, Conduct, Discipline and Other Conditions of Service) Rules, 2022", and No new certificate/ document will be entertained.

- 1. Before downloading the Verification Call Letter, from their individual Profile under 'My Account' at the appropriate link provided therefor, the candidates should check very carefully discrepancies, if any, and bring to the notice of Recruitment Cell, H.P. High Court, without loss of time, through e-mail i.e. arrecruitment-hc@hp.gov.in
- 2. The candidates are allowed to appear for evaluation/ document verification, in the Batch, Date and time slot allotted to them and no request for a change of date time & batch will be entertained.
- 3. The candidates are required to paste a passport-size latest photograph duly attested by the Gazetted Officer, in the space provided on the Verification Call Letter. No candidate will be allowed to appear for evaluation/ document verification, without Verification Call Letter.
- 4. The candidates are required to report at the venue half an hour before the scheduled timings along with original testimonials/ documents i.e., Verification Letter, ID Proof, Educational Qualification Certificate(s)/ Matric Certificate, Category Certificate, Sub-category (i.e. Physically Handicapped) Certificate and one-set of photocopies of the same duly attested by the Gazetted Officer.
- 5. The candidates are also required to bring one of the authorized Photo IDs (i.e. Aadhaar Card/ Driving License, Voter ID or ID of any recognized organization etc.) with them and it must be original, valid and not expired. Photocopy & scanned copy of Photo IDs in mobile phone are not acceptable.
- **6.** The candidates must note that their admission is strictly provisional and on the basis of declaration made by them on the online application form/verification call letter and only those documents which were uploaded at the time of submission of online application will be verified from original.
