INSTRUCTIONS TO THE CANDIDATES -WRITTEN EXAMINATION

(For the post of Additional District & Sessions Judge by way of Limited Competitive Examination)

PAPER-I

- USE/POSSESSION OF ELECTRONIC GADGETS LIKE MOBILE PHONE, iPHONE, iPAD, PAGER, CALCULATOR etc., IS NOT PERMITTED.
- 1. The Question Booklet contains a total 200 multiple choice questions. After opening the seal of question booklet, candidate must ensure that there are 200 questions from serial numbers 1 to 200. If any question is found to be missing or any other discrepancy is observed, it must be brought immediately to the notice of Invigilator and should ask for replacement of question booklet. Such request will not be entertained later than 30 minutes after commencement of Test. The paper will be of two hours.
- 2. Please use **ONLY blue or black ball point pen** to mark the answers.
- 3. Answers must be marked in the OMR answer sheet which is provided separately.
- 4. THERE IS NO NEGATIVE MARKING. Each correct answer carries one mark.
- 5. The OMR answer sheet should not be folded or wrinkled.
- 6. Write the Roll Number in the appropriate space (above) and on the OMR Answer Sheet. Any other details, if asked for, should be written only in the space provided.
- 7. There are four alternative answers to each question marked 1, 2, 3 and 4. Select one of the answers, considered as most appropriate and darken the corresponding circles, as illustrated in the OMR sheet under the title "correct method to encode". If there is any over-writing, rubbing or scratching, the machine may not read or capture the image in the OMR sheet. Therefore, the candidate should exercise caution.
- 8. In the OMR Answer Sheet provided to the candidate, the correct procedure for filling-up the OMR Answer Sheet is mentioned thereon.
- OMR Answer Sheet must be handed over to the Invigilator before leaving the Examination Hall. However, the candidate can carry away the Question Booklet and carbon copy of OMR answer sheet with him/her after the examination is over.
- 10. Answer sheet will be processed by electronic means i.e. computer. Invalidation of Answer Sheet due to incomplete/ incorrect filling of the answer sheet will be the sole responsibility of the Candidate.
- 11. Candidates are also required to bring Identity proof/ID card (i.e. Aadhaar Card, Driving License, Voter ID or ID of any recognized organization etc.) with them.
- 12. Bags, Mobile phones, pagers, books or any other electronic equipment capable of being used as communication or calculation devices, etc., will not be allowed to be taken inside the Examination Centre. The candidates will be allowed to take with them only the admit card, identity proof/ID (i.e. Aadhaar Card, Driving License, Voter ID or ID of any recognized organization etc.), ball point pen, pencil and clip board.
- 13. The High Court will not supply any article of Stationery except authorized OMR Answer Sheet.
- 14. The candidate should ensure that in case the question booklet or answer sheet is found mutilated, he should immediately report the matter to the invigilator and get the question booklet / answer sheet replaced. Nothing should be written on the Question Booklet except his/her Roll Number. Instructions on the Question Booklet & OMR Answer Sheet must be read carefully.

- 15. No candidate shall be allowed to use white fluid / rubber to change / erase their responses on the OMR Answer Sheet.
- 16. The Admit Card should be handed over to the invigilator on the commencement of examination.
- 17. Re-checking/ re-evaluation, for the Screening Tests will not be allowed in any case.
- 18. Impersonation cases/ malpractices would debar the candidate for life. The candidates shall not create any unruly scene at the Exam centre and if any candidate is found to have violated these instructions, then, they will be held disqualified by the High Court for that very exam.
- 19. The Answer key of the Screening Test shall be displayed on the official website of the High Court after freezing the OMR/Answer Sheets. The Objections, if any, received through official mail of the Registrar General i.e. rg.hphc@indiancourts.nic.in within three days of the declaration of result of paper-I, will only be entertained.
- 20. Attention of the candidates is invited to laws relating to prevention of use of unfair means which is an offence. Any examinee found of using unfair means shall be dealt with the provisions of relevant law(s) in addition to debarring him from the present as well as future examinations.
- 21. Candidates are advised to check the official website of H.P. High Court regularly, for obtaining updates with regard to the Screening Test.
- 22. Candidates are required to report at the venue of the examination half an hour before the scheduled timings, alongwith admit card and ID proof.
- 23. No candidate shall be admitted to the examination hall after 10 minutes of the commencement of examination. No candidate will be permitted to leave the examination hall until the expiry of full allotted time, except in exceptional circumstances, that too with the permission of the Centre Supervisor & question paper will not be allowed to be taken away.
- 24. Candidates are advised not to bring any precious articles with them to the Examination Centre and the High Court will not be responsible for any loss.
- 25. Admit Card is subject to the condition that if any ineligibility is detected at any stage, their candidature shall be liable to be rejected.
- 26. Candidates absent in the paper-I shall not be allowed to appear in paper-II.

INSTRUCTIONS FOR MARKING ANSWERS

- In this objective type of Screeing Test, the candidate has to choose one of the most suitable response from amongst four given choices in the question booklet. For example, in case of mentioning proper name of the Capital of Himschel Predesh against four suggestions viz. (a) Mandi, (b) Shimla, (c) Bilaspur, (d) Chemba, the most appropriate response containing circle (b) is to be blackened / encircled only with Blue or Black ball point pen in the OMR Sheet, as follows: A B C D
