Note: Only those documents will be verified, which the candidate has uploaded at the time of submission of Online Application Form.

- 1. Before downloading the Verification Letter, from their individual Profile under 'My Account' at the appropriate link provided therefor, the candidates should check very carefully discrepancies, if any, and bring to the notice of Recruitment Cell, H.P. High Court, without loss of time, through e-mail i.e. arrecruitment-hc@hp.gov.in
- 2. The candidates are allowed to appear for evaluation/ document verification, in the Batch, Date and time slot allotted to them and no request for a change of date, time & batch will be entertained.
- 3. The candidates are required to paste a passport-size latest photograph duly attested by the Gazetted Officer, in the space provided on the Verification Letter. No candidate will be allowed to appear for evaluation/ document verification, without Verification Letter.
- 4. The candidates are required to report at the venue half an hour before the scheduled timings along with original testimonials/ documents i.e., Verification Letter, ID Proof, Educational Qualification Certificate(s)/ Matric Certificate, Category Certificate, and one-set of photocopies of the same duly attested by the Gazetted Officer.
- 5. The candidates are also required to bring any of the valid authorized Photo IDs (i.e. Aadhaar Card/ Driving License, Voter ID or ID issued by any recognized organization etc.) with them in original. It must be valid and not expired. Photocopy & scanned copy of Photo IDs in mobile phone are not acceptable.
